REPORT OF CITY MANAGER

Mr. Dressler started his report to the Council.

Mr. Dressler invited everyone to the Juneteenth Celebration that will be held on Saturday, June 14, 2025 at the Jeter Watson Park.

The Peter's Mountain Landfill closure test run was a success. Public workers took citizens to refuse to Island Ford Transfer Station during this closure.

Mr. Dressler showed appreciation to the City's Finance teams for working on the upcoming 2025-2026 Fiscal Year Budget.

Paving is still ongoing throughout the City. On streets that needed to be repaired due to Columbia Gas pipeline upgrades.

The Casey Field House will be ready for the City Manager to perform his final inspection on Thursday June 12, 2025.

The Mid-City Mall Parking lot project is ongoing.

The City of Covington's Public Works building is currently undergoing improvements. The siding has been removed, and other improvements are scheduled for the near future.

The Mini Golf Course at the Jackson River Sports Complex is nearing completion. Electricity and Plumbing have been installed. The playground was installed. Mr. Dressler has already received many compliments on how nice the Mini Golf Course, Park, and walking trail have turned out. James Quantz, an Eagle Scout, is currently working on getting furniture for the Mini Golf Course. Mr. Quantz will use this project for his Eagle Scout project.

Greenbrier Youth Girls Softball was using the Jackson River Sports Complex for their tournaments. It rained over the weekend, but the Parks and Recreation staff were able to get the fields dry and ready for use for the girls.

VTARC is interested in an aquaponics program for our area youth for STEM. This project will engage our local children in technology and educate them on how to cultivate their own produce and plants.

Vice Mayor Forbes motioned to adjourn the regular meeting and go into Closed Session. with Councilman Hunter seconding. Followed up with an all in favor vote of "aye" by the Council.
